## Budget Q & A

#### Does the budget include any changes in academic programs for our students?

No. The Board of Education has continued all of the existing school day academic programs and courses the district currently offers.

#### Is Holley below the "tax levy limit"?

Yes. The Board of Education is proposing a 1.35 percent tax levy increase. The average tax rate will be approximately \$22.54 per \$1,000 of assessed value.

#### How is the tax levy different from a tax rate?

A tax levy equals the total amount of money the school district will collect from local property owners to fund its budget. It is calculated after factoring in all other revenues, including state aid. The tax rate - or the amount to be charged for every \$1,000 of assessed property value – is calculated by dividing the tax levy by the total assessed value of the school district, which is determined by the town assessment office and issued July 1. Tax rates cannot be calculated until August, when final equalization rates become available.

#### With the tax levy limit law, does the public still vote on a school budget?

Yes. Residents will still vote on a proposed school budget on May 16.

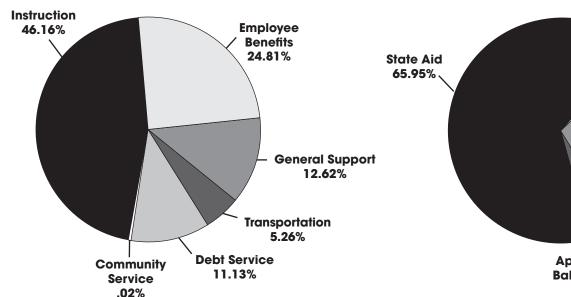

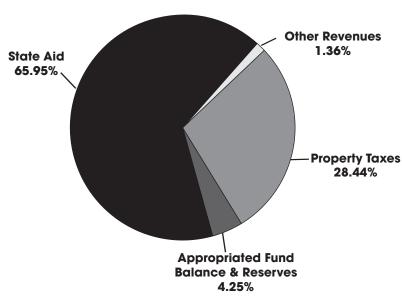

## 2017-18 Three-Part Budget

#### **Budget Expenditures**

#### Total Budget \$24,500,000

#### Administrative Component: \$3,181,939 Percentage of Budget: 12.99%

Provides overall general support and management activities including: employee benefits for administrative and clerical support staff, costs for administration and supervision of the district's two schools, staff development, Business Office operations, and Central Administration.

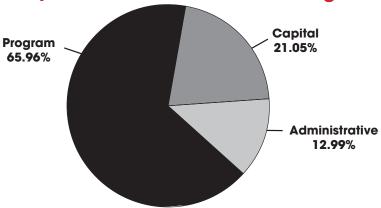
#### **Program Component: \$16,160,810** Percentage of Budget: 65.96%

Provides funding for the instruction of and educational support services for the District's 1,059 students. The program component also includes funds for: transporting 931 students daily, salary expenditures for all instructional staff, programs for special education services, benefits for instructional employees and retirees, workers' compensation and unemployment insurance.

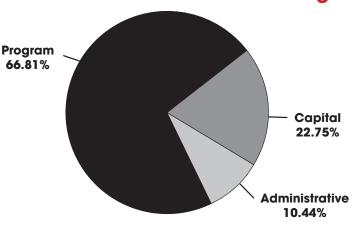
#### Capital Component: \$5,157,251 Percentage of Budget: 21.05%

Provides funds for maintaining two schools and surrounding property, utility services, debt service payments, and benefits for maintenance and custodial staff. This year it also includes payment two of three for the Monroe 2-Orleans BOCES Capital Project.

## **Board of Education Candidates**

## What you'll see at the polls

The wording that appears below is what voters will see ▲ on the ballot on Tuesday, May 16. Please take the time to review this information so that the language is familiar when you get to the polls on May 16.

#### **PROPOSITION NO. 1**

#### ANNUAL DISTRICT BUDGET \$24,500,000

"Shall the Board of Education of Holley Central School District be authorized to make the expenditures of the monies set forth in the proposed 2017-18 budget and be authorized to levy the necessary taxes to meet the estimated expenditures set forth in said proposed budget?"

#### **PROPOSITION NO. 2**

#### AUTHORIZING PURCHASE OF SCHOOL BUSES, PICKUP TRUCK, GROUNDS MAINTENANCE EQUIPMENT AND **CHORAL RISERS**

Shall the following resolution be adopted, to wit:

"Resolved, that the Board of Education of Holley Central School District be authorized to purchase various school buses (two large and two small) and a pickup truck with an aggregate estimated maximum cost of \$400,300; various buildings and grounds equipment with an aggregate estimated maximum cost of \$84,300; and choral risers with an estimated maximum cost of \$12,000; the total estimated maximum cost for all such items not to exceed \$496,600, with the cost thereof to be raised by the levy of a tax upon the taxable real property of the School District, to be collected in annual installments and partially offset by state aid, and in anticipation of such tax, such debt obligations of the School District as may be necessary (including obligations in the form of lease/purchase or installment purchase contracts having a term of not more than five years), not to exceed such estimated maximum cost, shall be issued."

#### **PROPOSITION NO. 3**

#### SUPPORT OF COMMUNITY FREE LIBRARY, HOLLEY, **NEW YORK**

Shall the following resolution be adopted, to wit:

"Resolved that the Board of Education of Holley Central School District, pursuant to Section 259 of the Education Law of the State of New York, be authorized and empowered to raise the sum of \$125,247 during the 2017-18 school year, to be used in support of the maintenance and operations of the Community Free Library, Holley, NY, said sum to be in addition to the funds to be raised to meet the estimated expenditures of the School District in the form commonly known as the school district budget."

## Dear Voters,

n May 16, when Holley residents are voting on the School Budget, we ask you to remember to vote on the Community Free Library Budget. As in previous years, the library experienced a significant decrease in state and county funding. To offset these financial difficulties, the Library diligently found other resources to supplement the budget through grants and donations.

This year, as promised, we increased our presence in the community and offered many programs for young and old alike. We hired a part-time librarian and increased our hours to include Saturdays from 10 a.m.-2 p.m. We offered adult programming in the form of "Wacky Wednesdays," which provided arts and crafts programs every month, and six computer programs taught our patrons the safest and easiest ways to use their new technology. In conjunction with Holley MS/HS, we are sponsoring an author visit to help teach young adults that they can overcome any difficulties and succeed in today's world. We are also pursuing more young adult participation in library programming and will offer some programs during the summer.

Children's programs are offered throughout the year and include a weekly story hour, the Summer Reading program, walking field trips for Elementary School students, and programs during winter and spring breaks. We also provide monthly Saturday story hours to reach as many children as possible in the area. Our Children's Room was enhanced by the purchase of educational toys and games. It is truly a learning center, as now it is utilized by area clubs and daycare providers.

If you haven't stopped in lately, we hope you will visit soon. On May 16, remember to vote on **Proposition 3** – the library needs your continued support to maintain its high level of service to the community.

## **Voter eligibility**

#### In order to be eligible to vote, you must be:

- 18 years of age or older
- a U.S. citizen
- a legal resident of the Holley Central School District at least 30 days immediately prior to May 16, 2017

#### Voters:

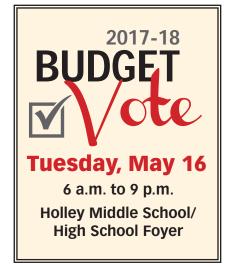
- Do not have to own property.
- Do not have to register in advance.
- **Do not** have to be a parent or have children in school.

#### **Proof of Residency:**

Voters must bring photo identification with them on May 16 in order to participate in the 2017-18 Budget Vote and Board of Education Election. Voting inspectors will ask voters to show their driver's license or other photo identification.

#### **Absentee Ballots:**

Residents unable to vote in person because of disability, illness, travel or college may request an application for an absentee ballot in person or in writing from Connie Nenni, District Clerk, at the Holley School District Office, 3800 North Main Street, Holley, NY 14470 or by calling 638-6316, ext. 2003. Absentee ballot applications are also available online at www. holleycsd.org. Applications must be received by the district at least seven days before the vote if the resident wishes to receive the ballot by mail. Residents who wish to pick up their absentee ballot in person may apply through May 15. In all cases, the ballot must be returned to the District Office no later than 5 p.m. on May 16. Ballots received later than 5 p.m. cannot be accepted under education law, regardless of postmark date.
