SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. The district is planning to purchase air conditioning units as well as air purifiers to assist in better ventilation. New cleaning equipment will be purchased to enhance the cleaning process in classrooms and common areas. Items such as steam cleaner, auto scrubbers and carpet replacement in certain areas as to make sure we have a clean and fresh environment for learning. Classroom furniture will be bought to assist in adequate spacing within the rooms. Some cafeteria equipment will be replaced to ensure proper temperatures in food preparation which assists in nutritious breakfasts and lunches for the students which promotes better learning as well as equipment to properly dispose of remaining food.

4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.

The district uses a variety of assessments to monitor student progress. Fountas and Pinnell is used to determine students' literacy needs. For example, these assessments determine a reading level for students so that teachers can provide appropriate and meaningful instruction. i-Ready is another assessment used with all students in grades K-8. These diagnostic assessments determine student proficiency and whether they are growing in math and reading. These assessments are aligned to the NY Learning Standards. Finally, benchmark assessments in grades 5-12 will be implemented this year to have more formal checks throughout the year to monitor student progress and respond accordingly. Teachers will be engaging in Professional Learning Communities regularly to analyze, interpret, and act on various data pieces.

5. In the space provided below, please describe how the LEA will use the funds it reserves under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year.

The district plans to host an annual summer camp program for students entering grades 1-9. This program is designed to support students' math, English Language Arts, and social-emotional learning needs. By focusing on the priority standards of math and reading, this program will target essential content and skills so that students enter the school year with fewer gaps in their learning. The district also plans to run before and after-school enrichment programs. This pandemic has resulted in unfinished learning, requiring our teachers to implement accelerated learning models. Having before and after-school tutoring and enrichment programs will help students have access to additional instructional time with teachers if they need support or simply additional time to reach proficiency on a standard.

6. In the space provided below, please describe how the LEA will spend its remaining ARP ESSER funds consistent with section 2001(e)(2) - the allowable uses of funds - of the ARP Act.

Interactive flat panels will be purchased to support students' technology skill development, as these interactive panels will allow teachers to integrate technology in more meaningful ways, such as having students collaborate with one another up at the board solving a problem. Updates to the school buildings, such as convection ovens, air purifiers, and air conditioning, will provide comfortable and nurturing learning environments where students' basic needs (nutrition, safety, shelter) are being met. Money is being set aside for remote learning, specifically to support sending students to a dedicated remote learning option as opposed to experiencing a hybrid option. Creating a dedicated 21st Century classroom will give teachers a learning space where they can have students stretch their creativity, collaborate, communicate, and critically think about content.

Funds will be used to purchase and implement high-quality learning materials that engage students and that are responsive to needs resulting from learning loss. Holley has a high economically disadvantaged population, which means that many of our students struggle with engagement in their learning as their focus is often spent on worrying about needs back at home. Curriculum writing will also strive to develop rich curriculum units that engage and challenge students with relevant and meaningful learning experiences. Through this process, teachers will also determine appropriate scaffolds to embed in curriculum units so that students, such as English language learners and children with disabilities, can still experience grade-level content with increased support. Additionally, the district will fund positions, such as a school psychologist and an instructional technology specialist, to provide additional support for students and teachers. The district and our community want students' social-emotional needs and technology skills to be supported and these positions will leverage more opportunities to do so. Interactive flat panels will also be purchased to support students' technology skill development, as these interactive panels will allow teachers to integrate technology in more meaningful ways, such as having students collaborate with one another up at the board solving a problem. Updates to furniture will support greater 21st Century skill development, such as collaboration being fostered by having flexible seating arrangements.

This has allowed the district improvement teams to monitor progress towards district goals and determine areas that needed to be targeted. These groups will be leveraged for direct feedback for our plans. As mentioned, school and district improvement teams that contain student, teacher, parent, and other stakeholders will meet monthly to evaluate our progress. Board meetings will also regularly discuss the plan during open sessions to be updated on the plan's progress and to determine areas that need to be re-evaluated as new needs develop.
