- January, 21, 2020, Governor Cuomo issued the Executive Budget
- Typically, the Legislature and the Governor meet to discuss budget items to arrive with an agreed upon budget by April 1st
- March 18th, Governor Cuomo closed all schools to students due to the COVID-19 pandemic
 - What would happen with students instruction?
 - What would happen to employees?
 - What would happen to the budget vote?
- March 31st, NY Legislature and Governor Cuomo reached an agreement for the 2020-21 state budget

OVERVIEW-CON'T

- On April 1st, the new State Aid runs were released
 - What that showed was:
 - Reduction in State Aid, not only from 2019-20 but what would become known as 'The Pandemic Adjustment' (\$371,643)
 - New line item, named 'Federal Cares Restoration' +\$371,643
 - The ability to review the State's financial status at 3 measurement periods, with the authority to make mid-year State Aid reductions if necessary
 - April 1-30
 - May 1-June 30
 - July 1 December 31



• What about the Budget Vote?

On Friday, May 1, 2020, Governor Andrew Cuomo issued Executive Order No. 202.26 which modified the rules under which school districts are to conduct the 2020 annual meeting for the election of school board members and budget votes.

Statewide uniform voting date

•School board elections and budget votes originally scheduled for May 19, 2020 will now take place on June 9, 2020. **Public Notices**

•The manner for providing public notice of the annual meeting remains unchanged, except that the number of required publications has been reduced from four to two.

•The first notice must be no later than 28 days before the election, and include notice for an adjourned budget hearing.

Postcard Notice

•School districts must send out postcard notice which details the date of the election, date of the budget hearing, and a definition of qualified voter.

Manner of Voting

The annual meeting for the election of school board members and budget votes will take place remotely.
Qualified voters will vote only be absentee ballot.

Absentee Ballots

•School districts must send out an absentee ballot to all qualified voters, with a postage paid return envelope for any election held on or before June 30, 2020.

Report Cards

•School districts must submit their report card to the State Education Department no later than May 22, 2020 (18 days prior to June 9).

•The Department must make its compilation available electronically, at least by June 2, 2020 (7 days prior to June 9).

School Board Elections

•There will be no minimum threshold number of signatures required for individuals to be placed on the ballot, except that they must meet all other requirements, including applicable residency and age.

•Candidates will be listed on the ballot alphabetically.





PROPOSITION #1 APPROPRIATION BUDGET

Shall the following resolution be adopted, to wit:

"Resolved, that the budget for the Holley Central School District (the "District") for the fiscal year commencing July 1, 2020 and ending June 30, 2021, as presented by the Board of Education of the District, is hereby approved and adopted and the required funds therefor are hereby appropriated and the necessary real property taxes."

Budget Appropriation - \$25,780,000

PROPOSITION #2 AUTHORIZING PURCHASE OF REPLACEMENT SCHOOL BUSES

Shall the following resolution be adopted, to wit:

"Resolved that the Board of Education of Holley Central School District be authorized to purchase replacement school buses at an aggregate estimated maximum cost of \$315,000, with the cost thereof to be raised by the levy of a tax upon the taxable real property of the School District, to be collected in annual installments and partially offset by state aid, and in anticipation of such tax, such debt obligations of the School District as may be necessary (including obligations in the form of lease/purchase or installment purchase contracts having a term of not more than five years), not to exceed such estimated maximum cost, shall be issued."

PROPOSITION #3 SUPPORT OF COMMUNITY FREE LIBRARY, HOLLEY, NY

Shall the following resolution be adopted, to wit:

"Resolved that the Board of Education of Holley Central School District, pursuant to Section 259 of the Education Law of the State of New York, be authorized and empowered to raise the sum of \$183,773 during the 2020-2021 school year, to be used in support of the maintenance and operations of the Community Free Library, Holley, New York, said sum to be in addition to the funds to be raised to meet the estimated expenditures of the School District in the form commonly known as the school district budget."

BUDGET VOTE PROCESS-NEW

- Qualified district residents will receive an envelope in the mail that will include the following three items:
 - 1. An official ballot to be completed
 - 2. A smaller envelope that has a Statement of Absentee Voter on the back
 - 3. A larger self-addressed, stamped envelope addressed to the Holley Central School District
- After completing the ballot, fold and enclose it in the envelope that has the Statement of Absentee Voter on the back.
- Make sure the envelope is sealed.
- Sign and date the back of the envelope. You only need a witness' signature if you are not capable of signing the envelope and can only make a mark such as an X.
- If the front of that same envelope does not already include your name as the voter and your address, please fill that in. The poll site is not needed.
- <u>Please remember to sign the Statement of Absentee Voter</u>. We cannot open ballots that are not signed by the voter.
- Put the signed envelope that includes your completed ballot into the postage paid envelope that is addressed to the District Clerk and mail said envelope.
- All completed ballots must be received by June 9, 2020 at 5 p.m. in order to be valid.

- 3. Board of Education and Administration will re-work the budget and present to the public for a 2nd vote
