A Message from the BOE

The Holley Board of Education and administrative team have spent the past four months developing the 2020-21 School Budget. Our work began back in January with a series of budget workshops that focused on key elements of the budget from the Property Tax Cap to individual line items. With the added challenge of the COVID-19 situation and not knowing what the eventual impact will be on both our federal and state aid revenues, this has been an especially challenging year to prepare our budget.

Even with the unforeseen challenges we've faced this year, our guiding principle to prepare our school budget continues to be: **How do we provide the best instructional and extracurricular programs, yet still be fiscally responsible to our taxpayers to ensure the long-term fiscal health of our district?** The Board met on multiple occasions to review building and department budgets, enrollment projections, reductions and efficiencies, the use of fund balances and reserves, and how the Governor's budget and the possibility of additional cuts in state aid will impact our decisions.

An important part of our commitment to the Holley community is to provide a cost-effective, high-quality program for our students. While we made some reductions in our budget in order to meet our goals, we did our best to avoid cuts that had a direct impact on students and programs. To that end, we are pleased to present you with the proposed 2020-21 school budget. This year's budget did not increase at all from our current

year and contains a 1.95% tax levy increase, which is below our 2.11% NYS Property Tax Cap limit. We believe that this tax levy is fair, accounts for increases in contractual and inflationary costs along with decreases in our state aid, and still allows us to deliver high-quality instructional and extracurricular programs that are expected in our community.

In addition to the budget, we are also asking you to vote on two additional propositions as seen in prior years: Proposition 2, which will authorize us to purchase three buses (two full-size and one small) for replacement purposes; and Proposition 3, support the Holley Community Free Library.

All qualified district residents will be mailed an absentee ballot which will include a self-addressed, stamped envelope.

In order to be eligible to vote, you must be:

- 18 years of age or older
- a U.S. citizen
- a legal resident of the Holley Central School District at least 30 days immediately prior to June 9, 2020

If you are not sure if you will receive an absentee ballot, email HolleyVote@holleycsd.org and list your name, address and state you meet the qualifications to vote.

Ballots must be returned to Holley Central School District via mail or placed in locked ballot box outside District Office by 5 p.m. on June 9.

2020-21 Budget Facts:

- At this time, all current academic programs and services are maintained
- Reflects a 1.95% tax levy increase, which is below the district's property tax cap of 2.11%
- Proposition to purchase for replacement purposes, two large busses and one small bus
- Proposition for the Holley Community Free Library Tax Levy
- Governor Cuomo cut State Aid for 2020-21 by \$371,643 due to the state deficit as a result of COVID-19
- Federal Aid-CARES Restoration will be given for \$371,643; no procedures set as yet
- The Governor will be reviewing the State's financial position on June 30 and December 31
- If Governor Cuomo deems it necessary, additional state aid may be cut mid-year

The annual budget vote for the fiscal year 2020-21 by the qualified voters of the Holley School District, Orleans County, NY, will be held via absentee ballot. Ballots will be mailed to qualified voters and must be returned via the enclosed postage-paid envelope by Tuesday, June 9, 2020 by 5 p.m., prevailing time, at which time votes will be manually counted.

Completing Your Absentee Ballot

Qualified district residents will receive an envelope in the mail that will include the following three items:

1. An official ballot to be completed
2. A smaller envelope that has a Statement of Absentee Voter on the back
3. A larger self-addressed, stamped envelope addressed to the Holley Central School District

After completing the ballot, fold and enclose it in the envelope that has the Statement of Absentee Voter on the back. Make sure the envelope is sealed. Sign and date the back of the envelope. You only need a

witness' signature if you are not capable of signing the envelope and can only make a mark such as an X. If the front of that same envelope does not already include your name as the voter and your address, please fill that in. The poll site is not needed. **Please remember to sign the Statement of Absentee Voter. We cannot open ballots that are not signed by the voter.**

Put the signed envelope that includes your completed ballot into the postage paid envelope that is addressed to the District Clerk and mail said envelope. All completed ballots must be received by June 9, 2020 at 5 p.m. in order to be valid.








Provides funds for maintaining two schools and surrounding property, utility services, debt service payments, and benefits for maintenance and custodial staff.

Budget Q & A

Does the budget include any changes in academic programs for our students?

No. The Board of Education has continued all of the existing school day academic programs and courses the district currently offers.

Is Holley below the "tax levy limit"?

Yes. The Board of Education is proposing a 1.95% tax levy increase. The tax levy limit is 2.11%. The average tax rate will be approximately \$22.7166 per \$1,000 of assessed value.

How is the tax levy different from a tax rate?

A tax levy equals the total amount of money the school district will collect from local property owners to fund its budget. It is calculated after factoring in all other revenues, including state aid. The tax rate – or the amount to be charged for every \$1,000 of assessed property value – is calculated by dividing the tax levy by the total assessed value of the school district, which is determined by the town assessment office and issued July 1. Tax rates cannot be calculated until August, when final equalization rates become available.

With the tax levy limit law, does the public still vote on a school budget?

Yes. Residents will still vote on a proposed school budget on June 9 via absentee ballot.



Board of Education Candidates

Residents will be asked to elect two members to the Board of Education (BOE). The two candidates receiving the highest number of votes, including write-ins, will each be elected to a three-year term, effective July 1, 2020. The seats are now occupied by Robin Silvis and Andrea Newman. Three individuals have submitted candidate petitions. You may also write in candidate's names, but in no case can you vote for more than two candidates in total.

The following candidates have submitted petitions, and Nancy Manard MacPhee, Andrea Newman and Robin Silvis will appear on the ballot. Below are their profiles.

I am an active member of the Monroe County School Board's Association Board President's Committee. I miss my children's involvement in extracurricular activities and athletics at HCS. During their time in the district and for several years after they graduated, I volunteered daily for responsibilities such as team mom, cooking for events, working events and travel. We have always had, and continue to have, an amazing community; it is truly a pleasure and honor to be a member of and contributor to this community.

What motivates you to run for the Holley Board of Education? The first reason, and the one that is closest to my heart, is that I am proud to be a part

We all send our children to school. Most of us don't really think about what it takes to run this business of educating our children and marketing the competitive young adults that leave here to further their education or begin their adult working lives. I think about that a lot. Being on the Board gives me the opportunity to help guide, run and hopefully, bring a large portion of the community's opinions and beliefs to the table. I began sitting on the Board so many years ago that I can honestly say that I do not wish to be done. I like being proud of our accomplishments. I want to be given the chance to continue this journey and work for the community as a representative of them on this Board.

Holley Community Free Library Proposed 2020 Budget

Difficult times mandate difficult decisions. Our community library has adopted the new isolation in place policies put into effect by our Governor. We have closed our doors, but we've opened new windows. Our children's programs continue online, your library card entitles you to access any database in the NIOGA system (movies, books, CDs, e-books, etc.), and all materials are fine-free when isolation ends.

Passing the 2018 budget made the position of Children's Librarian permanent. Miss Grace has since offered 129 programs attended by 1,674 people, including 17 summer reading programs. The 2020 budget includes funding to increase her hours so that she can continue to expand programming for children and families.

Passing the 2019 budget enabled Library Director Sandy Shaw to add additional programs for adults. Twenty-two programs were attended by 244 people. Both of our librarians have been working on outreach, teaming up with the Holley Elementary School (ES) and Middle School/High School (MS/HS), borrowing books from the MS/HS Library for students to read during the summer, and partnering with Monroe 2-Orleans BOCES and Grace's Place to share resources. With this budget in place, our circulation of children, young adult and adult materials has increased from 20,793 in 2018 to 22,774 in 2019.

In addition to educational programming, the library has reached out to provide services and programs to the community such as Christmas Cards for Veterans, a hat and mitten tree for children at Holley ES, Food for Fines donations, a Community Christmas Party, and delivery of books to shut-ins. In conjunction with Holley Gardens Management, we have planned on creating and maintaining a mini-library for residents at Holley Gardens when it opens in the spring.

Your library consistently seeks to be fiscally responsible through efficient use of grants and state aid to secure improvements at no cost to the community. A new children's room and replacement of a roof and furnace were done at no community expense. We have recently applied for a grant to fix our building and make it all ADA-compliant. Once the grant is received, the cost for these items will not be passed on to our community. This is one of many grants that have been written this year to enhance the library for our patrons.

The proposed budget for 2020 is \$183,773, a 7.8% increase. Staff salaries have been raised to the mandated NYS minimum. While cuts were made in many areas, quality of service is being maintained. A Town Hall style meeting is planned in the future to answer any questions you may have. Movies for children will be shown and snacks will be available during this session.

Propositions

The wording that appears below is what voters will see on the absentee ballot, which must be returned by 5 p.m. on Tuesday, June 9, 2020. Please take the time to review this information so that the language is familiar upon receipt of your absentee ballot

PROPOSITION NO. 1

Annual District Budget \$25,780,000

Shall the following resolution be adopted, to wit:

"Resolved, that the budget for the Holley Central School District (the "District") for the fiscal year commencing July 1, 2020 and ending June 30, 2021, as presented by the Board of Education of the District, is hereby approved and adopted, and the required funds therefor are hereby appropriated from the necessary real property taxes."

PROPOSITION NO. 2

Authorizing Purchase of Replacement School Buses

Shall the following resolution be adopted, to wit:

"Resolved, that the Board of Education of Holley Central School District be authorized to purchase replacement school busses at an aggregate estimated maximum cost of \$315,000, with the cost thereof to be raised by the levy of a tax upon the taxable real property of the School District, to be collected in annual installments and partially offset by state aid, and in anticipation of such tax, such debt obligations of the School District as may be necessary (including obligations in the form of lease/purchase or installment purchase contracts having a term of not more than five years), not to exceed such estimated maximum cost, shall be issued."

PROPOSITION NO. 3

Support Of Community Free Library, Holley, NY

Shall the following resolution be adopted, to wit:

"Resolved that the Board of Education of Holley Central School District, pursuant to Section 259 of the Education Law of the State of New York, be authorized and empowered to raise the sum of \$183,773 during the 2020-21 school year, to be used in support of the maintenance and operations of the Community Free Library, Holley, NY, said sum to be in addition to the funds to be raised to meet the estimated expenditures of the School District in the form commonly known as the school district budget."

In order to be eligible to vote, you must be:


- 18 years of age or older
- a U.S. citizen
- a legal resident of the Holley Central School District at least 30 days immediately prior to June 9, 2020

Voters:

- **Do not** have to own property.
- **Do not** have to register in advance.
- **Do not** have to be a parent or have children in school.

Absentee Ballots:

All qualified residents will vote via absentee ballot. Any individual who does not receive a ballot may request one by calling District Clerk Connie Nenni at 585-638-6316, extension 2003, or emailing HolleyVote@holleycsd.org and list your name, address and state you meet the qualifications to vote. In all cases, the ballot must be returned to the District Office no later than 5 p.m. on June 9, 2020. A locked ballot drop-off box will be available outside of District Office, adjacent to the Elementary School. Ballots received later than 5 p.m. cannot be accepted under education law, regardless of postmark date.
